INDIA: Church Set on Fire

During the night of June 12th, the Real Peace Church in Vayalur, Tamil Nadu, was set on fire by suspected Hindu nationalists. The fire destroyed the roof, which was made of coconut leaves and bamboo. By the time Pastor Ramesh noticed the flames and smoke, all the building's contents were burned and considerable structural damage had taken place. The pastor sees this as part of the ongoing persecution endured by the church which consists of approximately 100 members.

A police report has been filed, since the possibility of an electrical fire was ruled out because the building is not connected to any source of power. Despite the destruction and significant loss, Pastor Ramesh is able to say the following statement: "We don't suspect anyone in particular. People of all faiths come here to pray. Someone may have done it out of jealousy, but we forgive...." For more information on the persecution of Christians in India, go to our online [country report](#).

PAKISTAN: Family Discord and Blasphemy

A Christian man has been accused by two close family members of committing blasphemy in what appears to be the first case of its kind in Pakistan. Anwar Masih was arrested on June 2nd and charged under Pakistan's blasphemy law 295-C. Both his wife and

daughter are the ones accusing him of speaking against Islam.

Anwar's wife, Kausar Parveen, and their daughter, Samreen, operated a beauty parlour in Lahore. According to reports, Samreen began an affair with a Muslim man and became pregnant. She has since converted to Islam and married the man. All of this happened without the knowledge of Anwar. Once this father found out, he was understandably shocked and upset that the information had been withheld from him. In anger, he allegedly made comments about Islam, which Samreen recorded with her cell phone. That recording was turned over to police.

The situation has many unknowns as it relates to family dynamics. But it is clearly another case where the country's blasphemy laws are being misused. Nasir Saeed, Director for Centre of Legal Aid, Assistance and Settlement refers to this situation as "shocking

news." He states, "This is another example of the misuse of the blasphemy laws where a daughter gets rid of her father – and a wife, her husband – simply because he cannot accept what they have done." For more on the difficulties facing Christians in Pakistan, go to our [country report](#).

Firstly, we ask that you please intercede for this broken family. May God work in miraculous ways to restore these shattered relationships and minister His love and unity among them. Pray that those in authority will realize the numerous ways in which Pakistan's blasphemy laws are being abused and, as a result, make the necessary amendments to rescind this legislation. May mercy be extended towards Anwar in the midst of this troubling family situation, as the case works its way through the court system and the Holy Spirit works in the hearts of all involved.

CHINA: Wife of Imprisoned Elder Begs for Prayer

In December 2018, raids on the Early Rain Covenant Church resulted in the detention of more than 100 Christians. All have since been released except for Pastor Wang Yi, who is serving a nine-year sentence, and elder Qin Defu, who was sentenced to four years in prison for "illegal business operations." Qin's wife, Xiao Hongliu, has written a letter, pleading for fellow Christians to remember her family in their prayers. Below is that letter:

Dear brothers and sisters,

My name is Xiao Hongliu, I am Qin Defu's wife. I am begging for intercessory prayers for my family and me.

Defu has been in jail for more than six months. I had received his phone calls from the jail at the beginning of his sentence. Although the calls were only two or three minutes long, as long as I could hear his voice, I knew he was safe and alive.

Although I could not see him personally, I knew he was alive somewhere, where God could see him. However, since the end of March, I have not received his calls anymore. I have lost contact with him for more than 70 days, which makes my heart worry.

My reasoning makes me believe he is still alive, and that God is with him. However, not hearing from him is like an enemy. It hurts me so much that I suffer every day.

Normally, my husband would be managing the church, busy before and after, and I would merely hope for him to return home a bit earlier each night. Now my hope is causing me pain. Every day, I just want to receive one three-minute call from him, but this apparently has become an extravagant hope.

Dear God, please let me follow behind You, pulling on the hem of Your clothes, because I am no better off than the woman who suffered from a blood issue for 12 years.
