### **IRAN: Adopted Daughter Seized from Christian Couple**

An Iranian court has ruled that the adopted daughter of Sam Khosravi and Maryam Falahi be taken from them because they are "not fit" to be her parents. Although declared on July 19th, the ruling has only recently come to light after reports revealed that the couple's appeal was rejected on September 22nd. The court further ruled that since Lydia's birth parentage is unknown, she is to be considered a Muslim and thus must be raised by Muslim parents. It is expected that Lydia will be returned to the orphanage.

The Christian couple adopted Lydia from an Iranian orphanage in February 2019. However, Sam and Maryam were among eight Christians who were arrested for their faith in July of that year. Sam was sentenced to one year in prison, followed by two years of exile. Maryam, a nurse, was banned for life from working in the public sector. The recent rulings are currently under appeal. ### **NIGERIA: Lawlessness Heightens Call to Prayer**

The violence dominating areas of Nigeria continues as Fulani herdsmen terrorize village communities. Unfortunately, Christians are frequently targeted in these attacks. On September 18th, a church elder was shot in the stomach and his twin daughters kidnapped from their home in Katsina State. Thankfully, Ibrahim Garba survived the attack and received treatment in hospital. His teenaged daughters, Hassana and Hussaina, were released three days later.

Such incidents do not always end so positively, however, as was demonstrated in several other recent cases throughout Plateau State. On September 28th, the village of Kpachudu was also attacked by Fulani herdsmen. Two young women and a six-year-old boy were killed. A week before that, a 64-year-old Christian leader was lured out of his home with a phone call. Leaving the house to get better reception, he was ambushed and hacked to death with machetes.

On October 14th, Fulani militants ambushed Justine Patrick and two Christian companions as they were returning to Chaha village after working in the fields. The companions managed to escape, but Justine was killed with machetes.

These are only a few of the many cases of violence encountered by Nigeria's Christian population. The governor of Plateau State declared through a spokesman, "We will not allow these ugly incidences to return where helpless and innocent people are murdered in cold blood for no reason." He urged citizens to cooperate with security forces by providing information.

## REPORT UPDATE

### **PAKISTAN: Family in Hiding After Verdict**

Marilyn and her four young children have had to flee for their lives after her husband, Asif Pervaiz, was sentenced to death for blasphemy on September 8th (see [www.vomcanada.com/pk-2020-09-10.htm](http://www.vomcanada.com/pk-2020-09-10.htm)). Typically, even the families of those accused of blasphemy are targeted with acts of violence by opposing community members. In an effort to stay safe, Marilyn and her children are now in hiding.

Asif, 37, had already spent seven years in jail, leading up to his conviction last month. The case started with his refusal to convert to Islam or participate in Muslim prayers with others in the workplace. He was then accused of blasphemy for allegedly sending texts of this nature from his cell phone to the supervisor.

VOMC's ministry partner, Release International, is providing assistance to Asif and his family at this time. The conviction is being appealed, with the support of Saif ul Malook, a Muslim lawyer who has risked his life to defend Christians -- including Asia Bibi who was acquitted in October 2018 and then forced to flee the country with her family for protection.

*Please remember to pray for Asif Pervaiz while he awaits the outcome of his appeal in prison, asking for justice to prevail in his case. In the meantime, may the gracious love of God that Asif conveys in prison be used as a vibrant witness of our living Lord Jesus Christ so that many prisoners and officials will be drawn into the Kingdom of God. Additionally, pray that Marilyn and her children will experience His protection and provision while seeking safety in an undisclosed location. Continue to lift up the many other Christians throughout Pakistan who are facing persecution because of their faith in Christ.*
